Conditions for Permission

1. Permission to publish requires the proper completion, signing, and approval of this form. Until a fully executed copy of this form has been received by the applicant, permission is not granted. The ANS is responsible for safeguarding and preserving collections for both their physical and intellectual posterity. In order to insure this, as well as provide a balance between the needs of scholars and the rights of the copyright holder, all requests for publication will be considered on a case-by-case basis.
2. Permission to publish materials obtained from the Society's archival collection is granted for ONE-TIME USE ONLY. The responsibility for obtaining additional permission required for subsequent publication remains with the publisher of the material. This includes usage in a new edition or new format as well as usage in any promotional materials related to the book or periodical usage applied for above.
3. In granting permission to publish materials obtained from its archival collections, the Society does not surrender its own rights to publish the material or grant permission to others to publish them. This institution reserves the right to refuse to accept a copying order if, in its judgment, fulfillment of the order would involve violation of copyright law.
4. Materials must be published within three (3) years of the date of the signing of this agreement or this agreement becomes null and void.
5. Credit shall be given as follows: Item identification, date (if known), collection name (if appropriate), box number, folder number, item number (if appropriate), Archives, American Numismatic Society.
6. In consideration of being granted permission to examine any record on the terms set forth above, the undersigned expressly assumes all responsibility for observing all applicable laws of copyright, property right and libel. The

undersigned also agrees to exonerate, indemnify and hold harmless the American Numismatic Society, its board members, officers, employees and agents from and against all claims arising out of or in any way connected with the use which the undersigned makes or permits to be made of the materials used. The applicant assumes all responsibility for obtaining permission from any additional copyright holders, and is subject to any claims under copyright, libel or other laws that could be made as a result of the publication.
